

## Youth Consent Form

1. I agree and acknowledge that my child will participate in the Hobie 14 North American Championship entirely at their own risk and that they are medically fit to undertake such activities.
2. I assume full responsibility for my child's health and that the activities will in no way aggravate any conditions that are present. I will know in advance my child's condition or will seek advice before completing this form and will notify the Hobie 14 North American Championship if for any reason prior to the event this permission should be changed or withdrawn.
3. I assume full responsibility for ensuring that any health conditions associated with the participant are not communicable.
4. I give my permission to photograph my child, and the perpetual and non-exclusive right to use my child's image in communications produced by the Burlington Beach Catamaran Club (BBCC) and others. I waive any right to inspect or approve the finished communications. I understand and agree that there will be no monetary compensation for such use.
5. I agree to hold BBCC blameless for any personal injury sustained by my child or any other person and for loss or damage to any property, which my child has brought on the premises, whether caused by theft or any cause.
6. In consideration of the acceptance of a participant, I (PARENT/GUARDIAN) FULLY UNDERSTAND AND ACCEPT THE CONDITION that the Club, its Employees, Directors and Members are not liable for damage, bodily harm or loss of life of the child named above, which may occur during their participation in the event.
7. I have read and am familiar with the Ministry Approved Concussion Awareness policy.
8. I have read and will comply with the Ontario Sailing Athlete Concussion Code of Conduct.
9. I agree that if I am participating as a Coach/Instructor I confirm I have read and are familiar with the Ministry Approved Concussion Awareness policy.
10. I agree that in the event of any damages to program assets due to mishap or by a deliberate act to BBCC property caused by my child, I will be assessed the full cost to rectify the damage(s) or the replacement cost of the affected component.
11. I understand that I will be formally notified by email(s) of any damage related incident directly from the BBCC Board with any incident investigation results and/or an assessment of the actual cost of the damage(s).
12. Failure to pay the assessed damages within 30 days of receiving the notification email(s), I fully understand my child's future participation in any BBCC event may be denied without further notification.
13. BBCC assumes all participant owned equipment is fully insured for its full replacement value and liability coverage for collisions with other boats, owned equipment stored on-site, under transportation or relocated to a remote location is at the owner's risk. Any on-going securing of this equipment is the responsibility of my child.
14. I agree that contact information will be shared with Ontario Sailing, Sail Canada and other Government agencies that require statistical information for funding purposes.
15. BBCC, Ontario Sailing or Sail Canada will not sell, lease, rent or use this contact information for any commercial purposes.
16. This supersedes section 3.3(O) of the Ontario Sailing Privacy Policy.
